NOTICE OF AVAILABILITY AND PUBLIC HEARING ON THE
COMMUNITY DEVELOPMENT BLOCK GRANT RECOVERY (CDBG-R)
SUBSTANTIAL AMENDMENT TO
ANNUAL ACTION PLAN FOR FISCAL YEAR 2008-2009**

Interested persons are hereby informed of a proposed Substantial Amendment to the City of Melbourne's FY 2008-2009 Annual Action Plan for purposes of qualifying for and receiving supplemental funding under the American Recovery and Reinvestment Act of 2009 to fund the Spain Outfall Drainage Improvements, Phase I project.

The proposed Amendment will allow the City to apply for and use \$150,772 in Community Development Block Grant Recovery (CDBG-R) funds on a CDBG-eligible, public infrastructure project that addresses a community need and also creates or saves jobs, provides economic stimulus, and provides long-term economic benefit.

The scope of this includes drainage improvements only on Main and Swift Streets. The proposed work includes replacing existing old drainage pipes, upsizing several pipes, and installing rear yard drainage inlets. The pipe replacements and upsizing will improve the storm water runoff flow capacity and reduce local flooding problems.

The City of Melbourne will conduct a public hearing on 5/26/09 at 6:30 PM in the City Hall Council Chamber, 900 E. Strawbridge Avenue, Melbourne, FL 32901. The purpose of this hearing is to receive comments on the City's proposed Substantial Amendment, including how the funds will be used.
