TERMS & CONDITIONS FOR ISSUANCE OF ALCOHOLIC BEVERAGE PERMIT

- Alcoholic beverages may only be sold, served, and consumed in authorized areas and during the Use Period. Alcoholic beverages may not be served or consumed outside of the Facility or in parking areas. Glass bottles and containers are not permitted in any park. Alcoholic beverages are strictly prohibited in playground areas.
Applicant/User affirms that all applicable statutes and ordinances regarding the sale, possession, and consumption of alcoholic beverages are complied with during the Use Period, and that the event will not unduly interfere with the enjoyment of the park facilities by other citizens. Applicant/User ensures that no alcoholic beverages will be dispensed to minors.
Applicant/User shall leave the Facility and the surrounding area clean, orderly, and free and clear of any obstruction, rubbish, or litter.
Failure to comply with the terms of this Alcoholic Beverage Permit will result in the forfeiture of the security deposit.
This Alcoholic Beverage Permit is not transferable.
